## Terms & Conditions (T&C)

### 1) Hourly Charges:

- a) Rates below exclude petrol.
- b) The Hirer is fully responsible to check the accuracy of the car mileage and petrol level before moving off from PREMIER's premises.
- c) The Hirer is required to refuel the petrol to the same level prior to the return of vehicle at their own expense. Otherwise, cost of refueling is chargeable at \$0.38 per km. (prevailing GST applies).
- d) Hourly rental plans are only valid from Mondays to Fridays, excluding the period during Public Holidays, or 3 days before Chinese New Year and Hari Raya Puasa.
- e) Rates are subjected to change without prior notice.

### 2) Rental Period:

- a) Minimum rental charge is one hour (60 mins). Any unutilised rental usage (minutes/hours) are not refundable.
- b) In the event of any accident case, any unutilised rental usage (minutes/hours) at that point of time will not be refundable.

### 3) Extension of Hourly Rental:

In the event that you would like to extend your hourly rental beyond the agreed date of return, it is important that you advise Premier in advance for insurance coverage purposes.

### 4) Vehicle Movements:

All Hourly Rentals are strictly for Singapore use only. Should any vehicle be found entering Malaysia illegally, the Hirer will not be protected by any Insurance coverage and shall be fully responsible for all first and third party liability for damages, fire or theft and all other costs arising from the damages occurred in Malaysia.

### 5) Age Limit and Driving Licence:

The Hirer must be at least 23 years old and not over 65 years old of age and in possession of a valid local or overseas international driving licence with driving experience of more than a year.

A foreigner holding a valid foreign licence may drive in Singapore for a period of not more than 12 months. A Singapore driving licence is required after 12 months. Those on short-term social visit may drive with their foreign licence. For licenses not written in English language, an International Driving Permit or an official translation in English language is required.

**6) Insurance:**

The hourly rental rates include third party liability and property damage. Hirers are always responsible for the amount of “Non Waiverable Excess (NWE)” for each and every accident (Prevailing GST applies).

The Hirer accepts NWE on the condition that each and every accident damage, fire and theft to the hired vehicle is reported to Premier’s office within 24 hours. If there is bodily injury, the hirer must report to the Singapore Traffic Police and the original copy of the accident report must be forwarded to Premier’s office as soon as possible. For non-injury motor accident reports, the hirer is required to complete a non-injury motor accident report form which can be obtained from Premier’s office. Hirers shall be fully liable for any damages, fire and theft arising from unreported accidents/damages to Premier's vehicle.

**7) Non-Waiverable Damage Excess (NWE):**

**For Premier GO Lite Membership, Collision Damage Reduction (CDR) is included;**

- a) The Hirer’s liability is unlimited and the above-mentioned NWE does not apply in the following cases:
- b) Any loss or damage to the Vehicle not caused by an accidental collision;
- c) Any damage caused by sandblasting;
- d) Windscreen damage [unless WSI is purchased]
- e) Cost of rectifying any tyre damage not attributed to normal wear and tear;
- f) Cost of replacing any accessory from the Vehicle.

**8) The Hirer is not protected by any insurance cover in the case of:**

- a) The use of the Vehicle for hire or reward, driving tuition, racing, pace making, speed trials or any other sporting or racing competitions;
- b) The use of the Vehicle for transportation of any narcotics, contraband or for any illegal purpose;
- c) The use of the Vehicle while under the influence of drugs, narcotics, alcohol, or any substance that may impair or affect the ability of the driver to properly manage and drive the Vehicle (under Singapore’s Traffic Police Rules & Regulations);
- d) Illegal entry into Malaysia and Thailand;
- e) Negligent driving defined under Singapore’s Traffic Police Regulations and/or the use of the vehicle by an unauthorized driver.
- f) Any loss or damage to the Vehicle caused by fallen tree or fallen street lamp or fallen traffic light or fallen signboard or any fallen object occurring naturally as an Act of God.

- g) Any loss or damage to the Vehicle caused by the intentional or malicious throwing of an object or objects at the Vehicle by person or persons known or unknown.

**9) Rental rates exclude Personal Accident Insurance (PAI):**

PAI can be purchased at S\$5.00 per day (Prevailing GST applies). PAI covers against Loss of life and medical expenses caused by a sudden, unforeseen and fortuitous event whilst the Hirer and/or Passengers and/or Authorized Driver is driving in, boarding or alighting from the said vehicle.

PAI provides a lump sum compensation of S\$35,000 for death and up to a maximum claim of S\$5,000 on medical expenses for the Driver. The coverage for passengers will be S\$25,000 on lump sum compensation for death, to be shared among the passengers up to a maximum number of 4 passengers or more based on the legal capacity of the said vehicle.

**10) Rental rates exclude Windscreen Insurance (WSI):**

- a) 1.6 litre: WSI can be purchased at SGD \$5.00 per day (Prevailing GST applies).
- b) 2.0 litre: WSI can be purchased at SGD \$10.00 per day (Prevailing GST applies).
- c) MPV: WSI can be purchased at SGD \$15.00 per day (Prevailing GST applies).

**11) Personal belongings and valuables:**

The Hirer undertakes to remove all personal belongings and valuables from the Vehicle before returning the vehicle to PREMIER. Any items left in the Vehicle shall be at the Hirer’s own risk and PREMIER shall not be responsible or liable for the loss of or damage to any personal belongings or valuables.

**12) Misplaced/Damaged of Car Key:**

In the event that the car key is misplaced or damaged by the Hirer, the Hirer shall be responsible for the cost of replacement and a service charge will be levied (prevailing GST applies).

**13) Parking Charges, Traffic Fines and Toll Fees:**

All parking charges, traffic fines, ERP and toll fees will be the responsibility of the Hirer.

**14) Smoke-Free car:**

Smoking is strictly prohibited in the vehicle. The Hirer shall bear the cost of SGD \$200.00 for removing any offensive /bad odour in the Vehicle (Prevailing GST applies).

**16) Terms of Payment:**

An estimated total rental charge is payable prior to the start of the rental and all adjustments shall be made and paid accordingly at the end of the rental. Premier recognizes and accepts all major debit/credit cards.

**17) Goods and Services Tax (GST)**

Prevailing Goods & Services Tax will be levied on all charges.
